



Early Voting by Mail for the Special Town Election February 25, 2021

EARLY VOTING BY MAIL. A new "modified" early voting by mail provision was included in the legislation voted before the end of 2020 and will be applicable to all local elections held before

March 31, 2021. Upon application, any voter may, through "any form of written communication", file a request with the Clerk's office to vote early by mail.

There will be no "in person" early voting sessions.

Please find printed in this Newsletter a 2021 Municipal Election Early Ballot Application. As a registered voter you are strongly urged to vote safely from home using this process. The polling area will be open for in person voting on February 25th upstairs in Town Hall from 12:00 pm (noon) Until 8:00pm.

All voters will be **required to wear masks** for your safety and the poll workers safety. All Election workers will be wearing gloves and masks. The polling area and lobby will be wiped down with disinfectant after each voter. Social distancing will be mandatory which includes the required 6^{ft} apart and no more than 10 people in the polling area at a time. We appreciate the voter's cooperation in following the guidelines set for us by our Select Board and the Governor of Massachusetts.

Shall the Town of Phillipston be required to reduce the amount of real estate and personal property taxes to be assessed for the fiscal year beginning July first, two thousand and twenty-one by an amount equal to \$97,763?

This figure is adjusted to account for the annual 2.5% increase of Prop Two and One Half over the last two years since the override was adopted. Two years ago, an override was passed to fund the Narragansett School District. Templeton did not vote the override, so the funds were never disbursed.

Any registered voter may use this application to request an absentee ballot for a local election being held on or before March 31, 2021.

Completing the Application

- Voter Information Provide your name, legal voting address, and date of birth. Telephone number and e-mail address are optional fields.
- Ballot Information Provide the address where you want the ballot mailed.
- Special Circumstances If you are assisting a voter in completing this application, complete this section.
- Sign your name. If you require assistance in signing the application, you may authorize someone to sign your name in your presence. That person must complete the assisting person's information in Section 3.

Submitting the Application

Send the completed application to the local election official at your city or town hall.

Applications can be mailed or hand-delivered. Applications may also be submitted electronically by fax or e-mail, as long as your signature is visible.

Please allow ample mailing time for this application and for the ballot. Ballots must be returned to your local election official by Election Day.
